(一) 申請時段

- 本校將於 2026 年 7 月 7 日（星期二）至 7 月 10 日（星期五）期間接受 2026 年 9 月入讀中一候補新生之入學申請。
- 曾申請本校本年度中一自行分配學位但未能成功者，亦需再次填寫申請表格及遞交有關文件。

(二) 申請辦法

- 申請者請填妥本校入學申請表格（下載後頁附件，或由 7 月 7 日開始可於辦公時間在本校校務處領取），並連同下列文件之副本，於 7 月 7 日至 7 月 10 日期間於辦公時間（早上九時至中午十二時，下午二時至四時）直接交回校務處。
- 所需文件
 1. 派位證及入學註冊證副本；
 2. 身份證明文件副本；
 3. 過去兩年的學校成績表副本；
 4. 獎狀及成就記錄副本；
 5. 學生相片一張。

(三) 面試

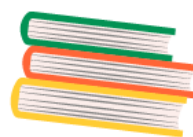
- 本校會即時安排面試。

Application Guidelines for S1 Places on the Waiting List (For S.1 Admission in September 2026)



1. Application Period

- The school will accept applications for admission to Form 1 (for September 2026) from Tuesday, 7 July 2026, to Friday, 10 July 2026.
- Applicants who previously applied for S1 discretionary places at our school but were unsuccessful must resubmit the application form and relevant documents.

2. Application Procedure

- Applicants must complete the school's application form, which can be downloaded from our website (attached on the back page) or obtained in person from the school office during office hours starting July 7.
- Submit the completed form along with copies of the following required documents to the school office during the application period (7 July 2026 to 10 July 2026) during office hours (9:00 AM–12:00 PM, 2:00 PM–4:00 PM).
- Required Documents
 - I. Copy of the allocation slip and admission slip;
 - II. Copy of identity document ;
 - III. Copies of school report cards for the past two year;
 - IV. Copies of awards and achievement record;
 - V. One student photo.

3. Interview

- Interviews will be arranged immediately upon submission of the application form.
- Interviews will be conducted in both Chinese and English
- Students and parents attending the interview must bring the original documents for verification.

4. Result Announcement

- The school will notify successful applicants individually via phone call.

5. Registration

- Admitted students must complete registration by the specified deadline to secure their place.
