**The Application for the Subsidy of the ‘Student Activities Support Grant’ (SAS Grant)**

To support students with financial needs to participate in life-wide learning activities organised or recognised by schools, the Education Bureau (EDB) set up in early 2019 the “Student Activities Support Fund”, the investment return of which will be used to provide the SAS Grant for application from schools starting from the 2019/20 school year. Details are as follows:

Subsidized Activities	Qualification for Application	Subsidies
Life-wide learning activities organised or approved by school (In or out of Hong Kong)	S.1 to S.6 students receiving Comprehensive Social Security Assistance (CSSA), full grant under the School Textbook Assistance Scheme or financially needy students(capped at 25% of the total grant)	The school would decide the amount of subsidy according to the actual amount of the funding received, the number of applicants and the number of school activities

Students who meet the qualification of the aforementioned subsidy application criteria are welcome to make application. Their parents/guardians need to fill in the reply slip as below and submit it to the class teacher on or before 20<sup>th</sup> September, 2021. Students have to pay the fees of each activity first. Subsidies will be given to the students concerned once their attendance and assignment meet the target. The sum of the subsidies will be refunded to the parents/guardians by the early of September 2022 (for S.1 to S.5 students) and the end of May 2022 (for S.6 students).
