Self-improvement Plan

In order to nourish our students to develop a sense of self-encouragement as well as self-improvement, our School has implemented a 'Self-improvement Plan'. Details are as follows:

- (I) The Plan in details:
 - 1) Students are encouraged to apply for the Plan of their own accord.

The Code of Practice on Using Student Lockers

- 1. The deadline of using locker is 1st June, 2024.
- 2. The usage of the locker is restricted to store textbooks, exercise books and learning materials for class. No cellphones, money, food or drinks or other materials not for use in class are allowed.
- 3. The borrower of the locker must take full responsibility of the safety of the materials in the locker.
- 4. The right of using the locker is confined to specific students only. No lending to others, sharing or exchange without permission from our School are allowed.
- 5. The borrower of the locker must clear the things in the locker within specific period, otherwise our School reserves the right to confiscate the things inside the locker.
- 6. The locker must be locked at all time. Once any lockers being found unlocked, our School reserves the right to disqualify the right to use the locker of the student concerned.
- 7. The key of the locker must be kept carefully. It should not be given to other students. If a student loses his/her key, he/she must inform the class teacher. He/she must not handle the situation by himself/herself.
- 8. Students are only allowed to use the lockers during the 1st recess, the 2nd recess, lunch time or after school so that it will not disturb other students in class.
- 9. Our School will check the locker in front of the student when necessary. The student concerned must co-operate with our School.
- 10. Students must keep lockers clean and neat. It is not allowed to smear it or put any stickers onto the lockers. If any lockers are found damaged, students must inform the class teacher to follow-up.
- 11. Students should learn to take care of and protect the property of our School. If any students are found damaging the lockers with intention or due to improper usage, they will be severely punished, and have to make compensation.
- 12. If a student withdraws from our School, he/she has to clear the locker and inform the staff of our school office within 7 days after the withdrawal. Otherwise our School will take it as an overdue case.
- 13. One day before test week/examinations/long holidays (Christmas, Chinese New Year and Easter holidays), students concerned must bring all textbooks and exercise books back home to study. They can use the lockers soon after examinations.
