 - 6. Photocopy of extra-curricular activities, services and prize records
 - 7. Photocopy of Hong Kong Identity Card or Birth Certificate (provide original for checking)
 - 8. 2 self-addressed stamped envelopes
 - * There is no need to provide a recommendation letter from primary school.
 - * Regardless of admission being accepted or refused, all the documents that are submitted to our school will not be returned.
 - * Please use A4 size paper for all photocopies.
 - * Each Primary 6 student can apply for only two schools, otherwise he/she will be disqualified by the Education Bureau (EDB).
- 2) Service hours for distribution and submission of application forms:

Monday to Friday: 9:00 am - 5:00 pmSaturday: 9:00 am - 12:00 noon

3) The number of Discretionary places is 30

- 4) All applicants will be invited to attend an interview on 4/3/2023 or 11/3/2023. Details of the interview will be announced separately.
- 5) Selection Results: The results of S.1 Discretionary Places Stage will be released on 31/3/2023. Parents will be notified about the admission in writing and via phone. Accepted applicants must go through the registration procedures published by the Education Bureau.

Admission Criteria and Weightings:

1. Academic Performance : 30% 2. EDB Ranking of Academic Performance : 20% 3. Conduct : 20% 4. **Awards** : 10% 5. Extra-curricular activities : 10% Interview : 10% 6.

∧Remarks:

- 1. In view of the COVID-19 epidemic situation, the EDB informs schools that submission of DP applications by post will be continued for this SSPA cycle. Should Primary 6 (P6) students/parents have genuine difficulties in submitting the Application Forms for Secondary One Discretionary Place (Application Forms) to secondary schools they intend to apply to in person by themselves or by their authorised representatives, parents could thoroughly consider the needs and associated risks, and arrange to submit the Application Forms and other documents required by the secondary school by post between 3 January (Tuesday) and 17 January (Tuesday), both dates inclusive (the postmark date should not be later than the prescribed deadline). After receiving parents' application by post, secondary schools should return the Parents' Copy of the Application Form to parents by for post for retention.
- 2. In line with the "Smart Government" strategy, the Education Bureau will implement comprehensive digitalization of S1 admission by phases starting from 2023. For parents registered as SSPA e-Platform users and bound their account with "iAM Smart+", apart from the paper Application Form. They may also choose to submit DP applications via the SSPA e-Platform.
